COMPETITION FOR THE ALLOCATION OF MONETARY GRANTS FOR STUDENTS ENROLLED AT THE SCUOLA DI MUSICA DI FIESOLE FOR THE 2018/2019 ACADEMIC YEAR

APPLICATION DEADLINE: 15th JANUARY 2019

ART. 1 – Purpose of competition and grant amounts

The Scuola di Musica di Fiesole non-profit Foundation is holding a competition to award a maximum of **10 (ten)** grants in the amount of € **500,00 each** (gross amount before required taxes to be withheld), for those students in difficult financial conditions, to enable them to continue their studies.

ART. 2 – Recipients

The above-mentioned grants are intended for students in financial difficulty and/or extremely serious family situations. Students enrolled for the 2018/2019 Academic Year may apply for these grants.

Students who didn't pay the registration fee for 2018/19 will be not admitted to the **economic support**.

ART. 3 – Requirements

In order to participate in the competition the student must meet **all requirements** listed below, by the application deadline:

- a) be enrolled in Scuola di Musica di Fiesole
- b) meet the following requirement regarding economic conditions:
 - ISEE less than or equal to € 20.000,00;

Those students who won a scholarship the previous year or those who have already been awarded a scholarship for the 2018-19 Academic Year may not apply. Those students who are not in good standing with respect to their course payments may not apply.

The ISEE certification must be valid. ISEE calculation can be processed at all INPS offices, City Hall offices or CAF offices.

Foreign students from countries outside the European Union must present documents relative to their economic and financial conditions, issued by the authorities responsible for the territory in which the income was earned and where the assets are held. The documents must be translated into Italian and legalized by the Italian diplomatic authorities for that specific territory or, where applicable, bear an apostille as required under current law. In the event of countries where there are particular difficulties in obtaining certification confirmed by the local Italian Embassy, the documentation can be replaced by a certificate in Italian language issued by the Embassy or Consulate in Italy of the country of origin, legalized by the competent Prefecture for that territory. In the case of Countries in which there are particular difficulties in issuing the certification attested by the local Italian Embassy, the documents can be replaced by a certificate in Italian language issued by the Embassy or a Consulate in Italy of the country of origin, legalized by the competent Prefecture for that territory.

In any case all documentation must include:

- *The number of components of the household;*
 - *The activity carried out by each member of the household, including brothers / sisters who have reached majority age. In the event that some household members are not employed, the documentation must prove status of unemployment or non-employment and indicate the amount of any unemployment benefits;*
 - *The period of employment of each household member (including whether it is a period of less or more than six months);*
 - *income earned by each household member, including brothers / sisters of majority age as well as other relatives age 18 years or older living in the household or, alternatively, the total overall family income;*
 - *The square meters of residential property and any other buildings owned; if the family dwelling is not owned by any household member, a special statement issued by the competent authorities is required, certifying that no member of the household is the owner of any properties;*
 - *The remaining amount of the mortgage to be paid on the family dwelling or other;*
 - *The value of the personal property of each and every member of the family owned.*
- All amounts must be expressed in Euros, based on the average exchange rate of foreign currencies, as determined in accordance with law.*

c) find themselves in one of the following serious situations (this list is merely illustrative and not exhaustive):

a. serious economic difficulties as a result of events such as job loss (unemployment, layoffs, bankruptcy, dismissal, etc.), death of the main income earner (with reference to the members of the entire household), the birth of a child or other life-changing events (these indications are intended to be merely illustrative and not exhaustive);

b. serious diseases that have affected the student or a member of the student's family, which in turn have affected the student's academic studies;

c. serious difficulties as a result of earthquakes or other natural disasters that have affected the student or his/her family.

Only those situations arising from events that occurred over the past two years, or were still in effect during the same time period, will be taken into consideration.

The application must be accompanied by appropriate documentation to support these statements. In the event of serious diseases affecting the student or a family member, appropriate certification, issued by the National Health Service or a specialist, must be provided.

ART. 4 – Presentation of applications

The application must be accompanied by all documentation proving financial difficulty, as indicated in Art. 3.

Applications lacking the above-mentioned documentation or submitted with incomplete information by the deadline will not be taken into consideration.

ART. 5 – Grant allocation

Grants will be awarded after consideration by the School Directors, whose decisions are final. They will assess all financially difficult situations, also taking into account the student's academic progress.

ART. 6 – Grant distribution

The Academic Office will individually notify all participants of the results of the competition by e-mail, at the address indicated on the application form. The grant will be deducted from the current cost of the annual tuition fee.

ART. 7 – Personal data

Personal information provided with the application for participation in the competition will be treated in compliance with the right to protection of personal data under Legislative Decree 30 June 2003 n.196.

The data will be used exclusively for purposes related to this competition. Processing will be done both electronically and on paper.

The provision of data is compulsory and any refusal may result in exclusion from the competition.
